Contest starts November 1, 2018. All photos must be submitted by December 5, 2018 in order to be eligible for the #MUTHHoliday Tradition Photo Contest. Participants may upload their photo depicting their holiday tradition at Zehnder's or Bronner's via the following methods:

- Upload to the #MUTHHoliday Tradition link provided on www.bronnersblog.com or on www.zehnders.com
- Or post on Twitter or Instagram and use hashtag #MUTHHoliday by December 5, 2018. Profile must be public in order for entry.

Ten finalists will be chosen by the Photo Contest Committee by December 9, 2018. Voting for the finalists begins on December 10, 2018 and ends December 20, 2018 at 12 noon. After the votes are tallied, the photo with the highest number of votes wins the grand prize. In the event of a tie, the winner will be chosen by the Photo Contest Committee.

Contestants must be 21 or older to participate. Zehnder's of Frankenmuth, Zehnder's Splash Village and Bronner's employees are not eligible for the contest.
