



## Snowfest Impressions Giveaway Contest Rules:

**Contest starts January 24, 2024. All photos must be submitted by February 12, 2024** in order to be eligible for the Snowfest Impressions Giveaway Contest. Participants may upload their photo depicting Zehnder's Snowfest via the following method:

**Five finalists will be chosen by the Zehnder's Snowfest Committee and voting for the finalists begins on February 15, 2024 and ends February 23, 2024 at 12 noon.** After the votes are tallied, the photo with the highest number of votes wins first place. The photo with the second highest number of votes wins second place and the photo with the third highest number of votes wins third place. In the event of a tie, the winner will be chosen by the Zehnder's Snowfest Committee.

Contestants must be 21 or older to participate. Zehnder's of Frankenmuth employees are not eligible for the contest.

Only one entry per fan per day is allowed and all photos must include subject matter relating to Zehnder's Snowfest including but not limited to, Snowfest activities, Snowfest snow sculptures, Snowfest ice sculptures and more. All photographs should accurately reflect the subject matter and the scene as it appeared. Photos that have been digitally altered beyond standard optimization (removal of dust, cropping, reasonable adjustments to exposure, color and contrast, etc.) will be disqualified. Multiple exposures that have been combined to produce a single "High Dynamic Range" image are acceptable. Images that do not meet these requirements may or may not be judged at the judging panel's sole discretion. Captions must accompany all submissions, and should include the subject of the image, the location the image was taken, and the name of the photographer(s). All photos are subject to approval and may not contain:

- Copyright materials - except for logos of Zehnder's of Frankenmuth and its subsidiaries
- Profanity or derogatory images
- Obscenity, explicit material, nudity, profanity, graphic violence, calls or incitement to violence, content or images that could be considered abusive, inflammatory, denigrating, or disrespectful to the Snowfest Sponsors, or to groups, individuals or institutions.
